ORDER:

In the G.O.1st read above, orders were issued according permission to Apollo Hospitals Educational and Research Foundation, Jubilee Hills, Hyderabad to establish Apollo College of Nursing, Murukambattu (v), Tirupati Road, Chittoor District to start B.Sc Nursing course with an intake of 50 (fifty) seats.

In the letter 2nd read above, the Chairman, High Power Committee has stated that the proposal for enhancement of seats from 50 to 100 at Apollo College of Nursing at Murukambattu, Tirupati Road, Chittoor District was received from the Principal, Apollo College of Nursing, Murkambattu, Tirupati Road, Chittoor District was forwarded to the Principal, S.V Medical College, Tirupati (Member Convener, District Level Team, Chittoor District) for verification.
- 3. In the letter dt. 25.06.2018, the Principal, SV Medical College and the District Level Team Tirupati has submitted inspection report in respect of enhancement of seats from 50 to 100 Apollo College of Nursing at Murukambattu, Tiruapti Road, Chittoor District stating as follows while recommending to enchantment of 50 to 100 seats from B.Sc (N) admissions per year "The infrastructure, clinical facilities and teaching staff are adequate as per the Dr. NTR UHS guidelines with modification of two class rooms of 100 capacity and nursing lab equipment (Medical surgical nursing, Community nursing and Nursing foundation). Hence Permission may be accorded for enhancement of seats from 50 to 100 for B.Sc (Nursing) course". The above is permitted by Indian Nursing Council.
- 4. The Chairman, High Power Committee, has requested the Government to pass appropriate orders in the matter in favour of the applicant.
- 5. The Government after careful examination of the matter has decided to accept the recommendation of the Chairman, High Power Committee and accordingly hereby accord permission to enhance the seats from 50 to 100 seats in B.Sc Nursing Course in Apollo College of Nursing, Murukambattu (v), Tirupati Road, Chittoor District under the management of Apollo Hospitals Educational and Research Foundation, Jubilee hills, Hyderabad. The management shall abide by the conditions in the GOs read above and the statutes of Dr. NTRUHS and such other rules / instructions issued by the Government from time to time in this regard.
- 6. The Registrar, Dr. NTR University of Health Sciences, shall take necessary action in the matter.
